Bridge lessons 2021

Grant Patterson has agreed to be our Tutor for Beginner Lessons 2021!

Discussion points included:

New players could start on Wednesday night bridge (more casual, fewer boards) Assigning experienced (and friendly!) mentors to each student Arranging survey of previous students (interest in returning? What put you off bridge? etc.) <u>NB Joe is happy to arrange email distribution & collection of the</u> <u>survey, but SOMEONE ELSE NEEDS TO DRAFT THE SURVEY.</u> We then entered something of a freeform discussion phase with several conversations going on at once. I have recorded what seemed like the pertinent points, but in the future it would be helpful (at least to your Secretary!) to have one person speaking at a time.

Discussion re: changing start time of play or reducing number of boards played in order to get home earlier. Consensus seemed to be that this was a decision to be made by the Divisions, not the General Committee.

Discussion re: establishing an Asset Register, possibly including updated valuations (esp. of our land and building). Penny & Grant to action?

Discussion re: future auditing of Club accounts. It seems doubtful that there is any legal requirement for audited accounts, however it is still specified in our Constitution:

Section 16.c "the Treasurer shall (present) an audited annual statement of accounts.... to the AGM."

Therefore, we will need to amend our Constitution (referred to as "Rules") as per Section 26 to make this change (you can read Sec 26 on the website under "Resources").

Back to Normal Procedure! (thankfully)

Card Dealers

Sue noted that our Card Dealers (esp. Judith Purvis) are our Club's "unsung heroes". The Committee supported the idea of giving them vouchers and doing our best to get them more support. Pauline to action.

Succession Planning

Pauline noted that this issue has become readily apparent over the last year and it needs to be included as a major topic for discussion at our next meeting. It was unclear if there will be any information circulated in advance. Pauline?
