Draft AGM Minutes: Agreed that discussion around merging grades should be deferred for at least another year to allow the Promotions Committee more time to progress their brief and to see the impact of clarifying playing rights.

Clarification of Playing Rights to Amend By Law:

It was moved that Club bylaw No. 6 (1) Playing Rights of Members be amended to read

"Any Silver player may, at any time, play in the Gold group, and any Bronze player may play in the Silver Group. When playing in a higher division, players are entitled to earn any C points and are eligible for any prizes" C Brand/B Mecchia – Carried

Noted that the process for amending the by laws set down in the Constitution (Rule 14 n) requires that the motion for amendment be displayed on the club noticeboard for at least 21 days, if there is no request by any 15 club members requiring that the motion should be put to a General Meeting then the motion will be confirmed by the committee subsequently.
