Matters Arising:

Beginner lessons: Grant happy with how lessons went, 15 graduated, Carole congratulated Grant & Joe on a great effort in teaching beginner players. The time they put aside to prepare and take the lessons and support the players was amazing.

Windows/Joinery: Three quotes to complete the double glazing and joinery windows project have been received, as follows:

Fairview Aluminium (supply and fit) \$23,275.90 including GST Brookland Aluminium (supply and fit) \$26,156.68 incl GST Kennedy Aluminium (supply only) \$20,597.20 incl GST

These were discussed and the decision was that Fairview Aluminium was preferred as this is the lowest quote and Fairview supplied the previous upgrade. The cost being \$20,239.91 excluding GST.

"To apply to Pub Charity Ltd for a grant of \$20,239.91 being the cost of supply and fitting of new window joinery and double glazed windows. The Committee authorises Grant Patterson to act on behalf of Club to apply to Pub Charity for above amount"

Improver Lessons: These have been a great success and we thank all the tutors.

Side Tables: Two final options were put on the agenda for side table design.

"To purchase 20 Metal Tables from The Warehouse for cost of \$15 each."

Tournament Sponsorship: Carole brought up that we should be contacting more businesses for sponsorship. Carole, Chris & Cath to form Committee to consider a sponsorship package. Any ideas of possible contacts to let them know.

BNZ Account Authorisers: Chris and Wendy still not authorised. **Incorporated Societies Law Changes/ Revised Constitution:** Club is required to re-register by 7 April 2026. Our constitution needs to be revised to include additional requirements and changes, and the new constitution would need to be approved at a Special General Meeting or Annual General Meeting. Time is running out. NZ Bridge mentioned in their last newsletter that a constitution pro-forma is likely to be included in a toolkit for clubs. Carole has queried when this will be made available.

Player Rights - Playing in Lower Divisions: The Promotions Committee have recommended a general principle and agreed exceptional circumstances, in response to Carole's email to them. Grant to come back with guidelines going forward.

Room Hire: Sign outside promoting hire and revised charges, Chris to see Kay next week.

Badges & Letterhead: Cath had supplied 3 options for both to give the club a more modern look.

Badges supplied from Timaru Engravers, no set up cost. Weekly run will be done with cost being \$15.50 with Pin & \$17.50 with Magnet.
